OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS APRIL 4, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of March 21, 2017, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Rawhouser. The motion carried.

The official bond for Bob Barrett, Clerk for the Recreation Board, in the amount of \$5,000 was approved and ordered filed with the County Treasurer.

Steve Lloyd, School District #9 Superintendent, thanked the Board for the use of the Fairgrounds for bus storage for the District. Lloyd reported the District bus barn construction may start in May.

Butch Penton, Road and Bridge Superintendent, reported on blading roads and possible wash outs, and a boggy spot in Bondurant. The Board discussed the Skyline Drive cattleguard and the fence that needs to be built by the Forest Service. The Board reported that there will be a meeting concerning the Skyline Drive rocks soon. North Piney gravel costs were discussed.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Crown Energy Partners LLC, \$66.17; Crown Energy Partners LLC, \$271.53; and XTO Energy, Inc., \$892.07.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve a request from the Sublette County Sporting Association for three beer permits for the Rendezvous Rodeos on July 6, 7, and 8, 2017 at the Pinedale Rodeo Grounds. The motion carried.

The Board signed a letter of appreciation for Cheryl Allen, who has retired as Sublette County's Veterans Services Officer.

County Clerk Mary Lankford reported on the "Ready for Workforce" program that is being sponsored this summer for Pinedale High School students by the Sublette County Chamber of Commerce, UW Extension, Sublette BOCES, and SERC. Funding for the scholarships at the end of the program was discussed. The Board requested more information about how many County participants would need to be funded before committing to funding.

The Board reviewed two resignations from the Golf Committee and directed that the vacancies be advertised.

The Board discussed the upcoming vacancy of a nursing position in the Public Health Nurse agency. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to request that the position be filled. The motion carried.

Cat Urbigkit and Sue Sommers presented a proposal for the production of the 2018 State of the County Report. The Board discussed distribution and production. The Board requested a reduction in printing costs by changing the paper quality and producing some pages in black and white for review at their next meeting on April 18th.

Sarah Hunt, representing SAFV, presented a resolution proclaiming April, Sexual Assault Awareness Month. It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to adopt Resolution No. 17-100308N proclaiming April, Sexual Assault Awareness month. The motion carried.

The Board directed that the Doyle property hay lease be advertised.

County Treasurer Roxanna Jensen discussed delinquent taxes that are uncollectible. Businesses that are not operating, mobile homes and equipment were discussed. It was moved by Commissioner Bousman and seconded by Commissioner Noble to leave the companies with County tax liens on the tax roll and remove the other delinquent accounts. The motion carried.

Undersheriff Lance Gehlhausen informed that Board that ALICE training will be held on April 17th and the Drug Task Force presentation will be at 3 p.m. on April 18th. Gehlhausen reviewed the NICE recording program and its difficulties. The Board approved a request to coordinate with the County's Owners Representative for two capital projects for budget purposes.

Old Business: Commissioner Rawhouser reported on reviewing scholarship applications and informed the Board that he will be participating by conference call on July 3rd. Commissioner Noble reported on the Sharkey contract and attendance at the WyoLink meeting. Commissioner Burnett reported on reviewing scholarship applications and discussing the Blue Room Engineering Assessment with John McLean and Todd Hurd. Commissioner Bousman reported on the NPL draft EIS that will be available in the summer, the State BLM Director's meeting and the repeal of Planning 2.0, by use of the Congressional Review Act. With the repeal, multiple users will be able to participate at the local level. Chairman Nelson reported on attending a WCCA meeting in Cheyenne with Supreme Court Chief Justice Burke to discuss court security.

Commissioner Bousman left the meeting to participate in a NACO conference call.

In accordance with the public notice published in the <u>Pinedale Roundup</u>, on March 17, 2017, a public hearing was held for the following applications:

 The request for a conditional use permit, by the Wilderness Church, applicant, proposing a public facility in the form of a church in the R-R district, located at Lot 5, Rocky Roads Subdivision. It was moved by Commissioner Noble and seconded by Commissioner Burnett to deny the application. The motion carried. The Board thanked Duke Edwards for his comments supporting the denial of the application.

County Planner Bart Myers proposed a letter to the DEQ concerning the revised septic rules. The Board directed Myers to prepare the letter.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to award the County Commissioners scholarships, being \$4,000 per school year to Micah B. Brown, Britney Covill, Abigail Ennis, Scott M. Noble, and Taylor Ruckman of Pinedale High School, and Adysan Applin, Alexis Bennett, Rachel Forrester, Lucas Hatcher, and Britany Tailor Kirkwood of Big Piney High School. The motion carried, with the vote being: Nelson-aye, Burnett-aye, Rawhouser-aye, Noble-abstained, and Bousman-excused.

Commissioner Bousman returned to the meeting.

Laura Clark, representing the Rural Health Care District, informed the Board that 32 months and \$160,000 had been spent on the CAH proposal and requested that the Board act upon either deeding the clinics to the District or giving the District permission to construct the CAH at their April 12th special meeting. The Board requested clarification and Clark informed them that it was simple and easy. Chairman Nelson informed Clark that the Board has been studying the Blue Room Engineering Assessment and that it will be sent to her and it will be posted on the County's website for the public. Nelson requested that Clark review the Owner Provided Equipment list in the Assessment and provide the estimates to the Board by the April 12th meeting. Clark informed the Board that the District was considering options and was not willing to share them with the Board.

Andre' Irey, Maintenance Superintendent, discussed the Pinedale Fire Hall roof, drainage at the Law Enforcement complex, the Ice Arena, landscaping, Fire Hall maintenance, Food Basket, summer projects, concrete at the Pinedale Library, Assessor's windows, Rendezvous Pointe ramp repair, Circuit Court roof, stage at the Southwest Sublette Senior Center, and ice dams.

Joan Mitchell discussed the property adjacent to the Southwest Sublette Senior Center.
