OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS AUGUST 4, 2015

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, Jim Latta, Stephen Crane of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the budget hearing of July 20, 2015, and of the regular meeting of July 21, 2015 were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Latta. The motion carried.

The official bonds for Chris James Nelson, Treasurer for School District #1 in the amount of \$25,000; and Skylar Wilson, County Surveyor, in the amount of \$1,000, were approved and ordered filed with the County Treasurer.

Butch Penton, Road and Bridge Superintendent, reported that the crusher had been picked up by Converse County and the County received \$400,000. Penton discussed water issues at Tim Thompson's property and possible road damage, and a power easement at Dry Piney. Penton informed the Board that any users of our pits must meet OSHA and MSHA standards.

Mike Jackson, representing Rio Verde Engineering, reported on the turn lane project at the County Shop. There were milling issues, but a two inch smoothing course will be applied with the project finished by the end of the week.

Mark Eatinger, representing Rio Verde Engineering, reported that the asphalt was done on the Calpet project and that approaches are being finished; that the asphalt was done on the Industrial Site project and that approaches are being finished. Timber is being removed on the Skyline Drive project and a culvert change order is expected.

Skylar Wilson, County Surveyor, reported that a road easement is still needed at the 4-H Barn.

Ron Gordon, Waste Management, discussed staffing and hours of operation at the Marbleton Landfill. It had been determined that additional staff was required to operate the new hours. The Board authorized one more month at the new schedule and will review at the end of August.

Chairman Nelson reviewed a certified letter that had been received by the Commissioners and the County Clerk from Garry Eiden, Sr. concerning the Pacific Steel contract for metal from the Marbleton Landfill. The Board directed the County Clerk to prepare a letter, informing Eiden that the County is receiving a floor price of \$56 per ton, for the Board to approve.

Laurie Latta, SERC Director, reported that she had been hired on a one-year contract to implement five goals identified by the SERC Board, and informed the Board about issues with no three-phase power at Sand Draw, the Wind River Brew Pub zoning, and poor internet.

It was moved by Commissioner Latta and seconded by Commissioner Nelson to appoint Rachel Grimes to an unexpired one-year term on the Pinedale Joint Powers Board. The motion carried.

It was moved by Commissioner Latta and seconded by Commissioner Nelson to re-appoint Sean Watts to a three-year term on the Big Piney Marbleton Joint Powers Airport Board. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve and sign the FY16 Veterans Service Office Memorandum of Agreement. The motion carried.

It was moved by Commissioner Latta and seconded by Commissioner Bousman to recess the meeting for an Executive Session with Undersheriff Mark Farrell, Capt. Wes Johnston, Capt. Gabe Torres, Sgt. Kam Peterson, and Deputy County Attorney Matt Gaffney to discuss personnel. The motion carried.

It was moved by Commissioner Latta and seconded by Commissioner Bousman to reconvene the meeting.

Chairman Nelson advised Undersheriff Farrell to deliver Law Enforcement contracts to the three towns.

Old Business. Commissioner Latta reported that he had discussed broad band with Superintendent Jay Harnack. Commissioner Bousman reported on meeting with the Governor's office on the Pilot Project in Cheyenne, State Parks, and BLM road policies. Chairman Nelson requested a letter of recommendation for Loni Morris, reported on meeting with Rachel Grimes, the Pinedale Planning and Zoning approval of a variance at the Pinedale Clinic and discussed a letter to the Forest Service concerning trail obliteration in the Hoback Basin.

In accordance with the public notice published in the <u>Pinedale Roundup</u> on July 17, 2015, public hearing was held for the following:

- 1. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve a variance request by David McGettrick to allow a garage to be constructed 15 feet from the right of way for Sauk Trail, where the required setback is 25 feet, located at Lot 33, Block 1, Barger Subdivision. The motion carried.
- 2. It was moved by Commissioner Latta and seconded by Commissioner Bousman to approve a variance request by James Pope to allow a residential structure to be setback 11 feet from an access easement and 19 feet from the rear yard, where the setback requirements are 30 feet from the access easement and 40 feet from the rear year; with a partial vacation and amendment to the existing plat, being a boundary line adjustment, changing the dividing line between the east half of Lots 13 and 20 of Jim Bridger Estates, First Filing, and Lot 10, Jim Bridger Estates, Seventh Filing. The motion carried.

Deputy County Attorney Matt Gaffney presented a utility easement for Union Telephone located in the area of the Fire Training Facility. The Board approved and the Chairman signed the easement.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to set the following mill levies for FY16:

Todd Hurd, representing Forsgren and Associates, and Maintenance Superintendent Andy O'Neal reviewed the following projects:

- 1. Pinedale Transfer Station Improvements. Upper slab curing. Siding tin, roof tin, trim around the overhead door, and flashing are complete. Crash bar to be complete in a couple of weeks. Soft spots to be repaired and stairs to the lower pad to be poured this week.
- 2. County Attorney Building. It was agreed to contract with American Roofing for \$85,980.00 for the roof repair. Premier contracts have been signed. Neighbor property issues were discussed.
- 3. Extension Office Building. Septic tank and leach field have been sized and the foundation preliminary design is complete.

The pre-cast foundation will be installed at the Marbleton Culvert project tomorrow.

Brianne Brower and Andy O'Neal, representing Sublette County, and Larry Braun and Cindi Berritt, representing Ice Arena users, discussed forming a group to lease the facility. Chairman Nelson requested Braun and Berritt present a proposal to the Board.

Chairman Nelson reported that the Salary Analysis prepared by ERG is available on the County website and from the County Clerk.

Ken Konicek, representing Tegelers and Associates, presented the Renewal Summary for 2015.
