OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS AUGUST 18, 2015

The Board of County Commissioners met in the Commissioners Meeting Room of the Sublette County Courthouse on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, Jim Latta, Joy Ufford and Stephen Crane of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the regular meeting of August 4, 2015, and the special meeting of July 10, 2015, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Latta. The motion carried.

Lew Gage expressed his appreciation for the maintenance on the Boulder Lake Road.

Mayor Bob Jones requested increasing the speed limit on Pinedale South County Road to 30-35 mph. The Board referred the request to Butch Penton, Road and Bridge Superintendent. Commissioner Latta inquired about striping the Fremont Lake Road by the ball fields.

Sealed bids were opened for the purchase of a loader. It was moved by Commissioner Latta and seconded by Commissioner Bousman to award the bid to Wyoming Machinery for the amount of \$268,663.00 with one trade and a seven year buyback. The motion carried.

Sealed bids were opened for the purchase of two motor graders. It was moved by Commissioner Bousman and seconded by Commissioner Latta to award the bid to Wyoming Machinery for the amount of \$392,944.00 with two trades and seven year buybacks. The motion carried.

Sealed bids were opened for the purchase of two pickups. It was moved by Commissioner Bousman and seconded by Commissioner Latta to award the bid for Pickup #1 to E&L Motors, Inc. for the amount of \$35,555.00; and for Pickup #2 to Frontier Ford, Inc. for the amount of \$34,132.00. The motion carried.

Butch Penton, Road & Bridge Superintendent, reported on culverts at the Harrower Pit from the Calpet project, and that cement had been poured on the Woods Wardell Bridge.

Mike Jackson, representing Rio Verde Engineering, reported on the turning lane project at the County Shop. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve Change Order #1 in the amount of \$19,540.00 for additional traffic control, due to safety concerns. The motion carried.

Mark Eatinger, representing Rio Verde Engineering, reported that the Calpet and Industrial Site projects were being striped, that shoulder work is in progress on Skyline Drive, and that the multi-plate will be installed on the Rim Road project next week.

Ryan McGuire inquired about repairs to the cattleguard on US Highway 191 going to the Pinedale Transfer Station. The Board referred him to WYDOT. McGuire thanked the Board for the Pinedale Transfer Station project.

Ron Gordon, Waste Management, reported that overtime was straightened out, that the Pinedale Transfer Station construction was complete and working well. Gordon discussed the need for a retaining wall. The Board referred the request to the County Clerk.

Shad Cooper, County Fire Warden, presented his monthly report.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve and sign a Mutual Aid Agreement for Fire Services with Sweetwater County. The motion carried.

County Fire Warden Shad Cooper and Commissioner Bousman discussed the Wildland Urban Interface and issues in Hoback Ranches.

It was moved by Commissioner Latta and seconded by Commissioner Bousman to extend the Memorandum of Understanding with the Rural Health Care District, for the use of the Sand Draw Ambulance to August 31, 2015. The motion carried.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Conocophillips Company, \$10,391.53;

Chevron USA, Inc., \$1,281.91; SWEPI LP, \$101,938.98; 15 adjustments in the assessed value for a deduction for the assessed value of \$385,958; and various adjustments in the assessed value for an increase of the assessed value of \$33,285.

Sheriff Stephen Haskell inquired about the payment of a Motorola bill. County Clerk Mary Lankford informed Haskell and the Board that the bill should be charged to the Communications Equipment budget. Haskell inquired about a bill for maintenance on the Hogsback radio site. Clerk Lankford informed Haskell that there is repair funding in the Radio Maintenance budget.

The Board reviewed a voucher submitted by Sheriff Haskell in the amount of \$1,595.07 for travel and expenses to the National Sheriffs Association Conference in Baltimore, in conjunction with a personal vacation. Clerk Lankford presented a memo to the Board reviewing the expenses and reporting that the eligible expenses for reimbursement totaled \$1,009.09. Chairman Nelson reviewed the negotiated expenses that were agreed upon by the Board, which totaled \$1,595.07. Clerk Lankford requested that her objection to the allowed expenses be noted.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve and sign an easement with Union Telephone at the Fire Training Facility. The motion carried.

County Clerk Mary Lankford reported on meeting with Stephen Crane, editor of the <u>Pinedale Roundup</u>, about Open Meetings, robust agendas, public electronic meeting packets, and transparency. Crane participated in the meeting and commented on transparency. The Board participated in a discussion of these items with comments from James Thomas and Kay Malkowski.

Commissioner Nelson discussed the 20% increase in legal advertising charged by the <u>Pinedale Roundup</u>, bringing the per column inch price to \$16.75, and presented a table of statewide prices, showing Sublette County with the highest price. Commissioner Latta discussed other newspapers and reviewed a proposal from the <u>Sublette Trader</u>, at a price of \$10.75 per column inch. It was reported that the County has paid \$182,513.21 over the past four years for legal advertising. The Board discussed the viability of using the <u>Sublette Trader</u> and taking advantage of the reduced price. The Board directed the County Clerk to contact the Business Manager at the <u>Pinedale Roundup</u> to obtain a rate sheet and inquire about discounts. Commissioner Bousman expressed his concerns about a conglomerate taking advantage of the County.

Old Business. Each Commissioner reported no old business.

Commissioner Joel Bousman left the meeting.

In accordance with the public notice published in the <u>Pinedale Roundup</u> on July 3, 2015, public hearing was held for the following:

1. Pursuant to Chapter 8, Section 1 of the Sublette County Zoning and Development Regulations entitled Administration, the Sublette County Planning Department proposes amending the Sublette County Zoning and Development Regulations to define, allow and establish standards for the operation of asphalt hot mix plants. The proposed amendment was recommended on a unanimous vote from the Planning and Zoning Commission. The Board discussed requiring a conditional use permit for this use. It was moved by Commissioner Latta and seconded by Chairman Nelson to table any action on the amendment and refer it back to Planning and Zoning, at their October 15th, to review the Commissioners' concerns. The motion carried.

County Assessor Jeness Saxton and Deputy County Attorney Matt Gaffney discussed the continuation of the County Board of Equalization hearings to September 14th, due to notice to the appellants.

Todd Hurd, representing Forsgren and Associates, and Maintenance Superintendent Andy O'Neal reviewed the following projects:

- 1. Pinedale Transfer Station Improvements. Project is complete.
- 2. County Attorney Building. Contractor has cut floor and found water service poured in the floor which will need to be replaced, submittals are being reviewed, and block and door frames have been ordered. Project cost per square foot was reported to be \$192.60. The Board discussed back up power for three months and agreed to not incur that expense.
- 3. Extension Office Building. Surveying today to complete site plan. Preparing to solicit quotes for the foundation the first week of September.

The Board reviewed maps provided by the Forest Service detailing proposed trail closures in the Hoback Basin. Seven members of the public participated in the discussion. The Board scheduled a public hearing to be held in the Lovatt Room of the Sublette County Library on August 25, 2015 at 7 p.m.
