

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MARCH 21, 2017

The Board of County Commissioners met in regular session in the Council Chambers of the Marbleton Town Hall, in Marbleton, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Stephen Crane of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of March 7, 2017, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Rawhouser. The motion carried.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve the Beard Agreement. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to approve the draft letter to the Forest Service concerning the rocks in the Skyline Drive easement. The motion carried.

Butch Penton, Road and Bridge Superintendent, reported on flood water in the County and discussed chip sealing and crack sealing. The Board requested that parking lots and County bike paths be included.

Chairman Nelson discussed a complaint about salt and sand on the Fayette Pole Creek road.

Mark Eatinger, representing Rio Verde Engineering, reported on the Skyline Drive easement from Central Federal Lands.

Ron Gordon, Waste Management, reported on hauling water out of the disposal pit, and the draft contract with Lincoln County for LaBarge solid waste.

The Chairman signed a reimbursement request from Homeland Security for \$180,950.00 for Unified Fire, and a final report for the Cora Townsite National Register application.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Southern California Public POW, \$33,228.45.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to approve Change Order #3 in the amount of \$1,120.27 and accept the Marbleton #2 Lysimeter project. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Noble to approve the FY16 Financial Audit report prepared by Leo Riley and Company. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Noble to approve a letter of support to the EPA for grant funding for the Wyoming Department of Environmental Quality, Air Quality Division. The motion carried.

The Board discussed the retirement of Cheryl Allen, Sublette County Veterans Services Officer, and directed that the vacancy be advertised.

Shad Cooper, County Fire Warden, presented his monthly report, and with Todd Hurd, representing Forsgren and Associates, discussed the following projects:

1. Update on Rocky Mountain Power rebate in the amount of \$1,240.95 for the Pinedale Fire Hall.
2. Pinedale Fire Hall roof and stucco siding. Estimates are being obtained for the roof replacement and Chairman Nelson requested options for repairing or replacing the stucco.
3. Proposed Daniel Fire Hall. Various locations have been reviewed and it has been determined that the property owned by the County is the best option. A five bay building is being considered with three bays for SCUF and two bays for Road and Bridge. Water wells were discussed. Planning will continue.

The Board approved disposal of metal and aluminum from the Fire Halls.

Cooper reported on a recent WyoLink meeting and requested approval of a letter of invitation from the Board to WYDOT officials for further discussion of future communication services in Sublette County. It was moved by Commissioner Noble and seconded by Commissioner Burnett to approve the invitation.

Hurd reported on the following projects:

1. Rendezvous Pointe Addition. Pre bid meeting later today.
2. Food Basket. Plans for the lean-to have been received and the site will be visited today.
3. Storm Drain on south side of Courthouse. Site will be inspected today and planning will begin.
4. Ice Arena Lights. Plan to request a Rocky Mountain Power evaluation.
5. Clinics Engineering Assessment. Assessment is on schedule and due on March 31st.

Old Business. Commissioner Rawhouser reported on the Fairgrounds and its snow removal and attendance at the Forest Collaborative meeting, CLG meeting, and the WPLI meeting. Commissioner Noble reported on attending the CLG meeting, WyoLink meeting, broadband meeting, Korean Peace metals presentation, and the DEQ/AQD Ozone meeting. Commissioner Burnett reported on Commissioners Corner and the discussion of health care and the CAH. Commissioner Bousman reported on the DEQ/AQD Ozone meeting, attendance at the Forest Collaborative meeting and the Boulder Travel Management Plan Open Houses, and discussed the BLM Flexible Grazing plans and need for funding for EA's.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve a letter of support for a funding request to the Governor for the preparation of the Grazing EA. The motion carried.

Chairman Nelson thanked Commissioner Bousman for his NACO report, and reported on the March 30th NPL meeting, mule deer migration comments, and the WCCA courtroom technology meeting in Cheyenne that he will attend on March 24th.

Kay Malkowski inquired about Johnson County population and mill levy regarding health care funding.

Jay Brower, Fairgrounds Manager, and Brienne Brower, reviewed the schedule for the buildings and the grounds through August.

Mark Pape, representing Tegeler and Associates, presented the liability and property insurance renewal information for 2017. It was moved by Commissioner Burnett and seconded by Commissioner Noble to approve continuing with One Beacon Insurance for the County's liability, property, and casualty insurance for the upcoming year for the premium amount of \$369,521.00, representing a 1% reduction in premium from last year. The motion carried. This coverage will include Sublette County, the Rural Health Care District, the Weed & Pest District, the Upper Green River Cemetery District, and the Big Piney Cemetery District.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to designate 1st Bank, a Division of Glacier Bank, as an official depository for County funds for 2017. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Rawhouser to approve the issuance of a catering permit to the Waterhole #3 for the Muley Fanatic Banquet held on March 11, 2017 at the Events Center at the Fairgrounds. The motion carried.

The Board decided that Commissioners Rawhouser, Burnett, and Nelson will review the County Commissioner scholarship applications for future discussion and award. Commissioner Noble declared a conflict of interest.

It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to appoint Commissioner Burnett to the Marbleton Joint Powers Board. The motion carried.

The meeting recessed for the Marbleton Joint Powers Board to convene. Upon its adjournment, the Commission meeting reconvened.

Joan Mitchell and Jim Robinson, representing the Senior Housing Joint Powers Board, discussed its need for a shop and storage for Senior Housing and requested that the Board consider deeding the remaining property adjacent to the Southwest Sublette Pioneer Center and the Senior Housing to the Senior Housing Joint Powers Board. The Board discussed a deed with restrictions.

Rachel Grimes presented the final proposal from Joe Sharkey for a County broadband assessment. It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve the proposal, pending review by the County Attorney. The motion carried.

The Board approved the construction of a wall in the rented office at the Sublette County Visitors Center.

Grimes reviewed the Connect Sublette/Teton project.
