

**OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
OCTOBER 17, 2017**

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Mack Rawhouser, Lance Nixon of the Pinedale Roundup, and Mary Lankford, County Clerk present. Commissioner Tom Noble was absent.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meetings of September 19, 2017, and October 3, 2017, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Rawhouser. The motion carried.

Butch Penton, Road & Bridge Superintendent, reported on bank repair at Pearson's and Beard's property, discussed Forest Service Roads, Schedule A agreements for local roads, and reported on willow removal on Ehman Lane.

Mark Eatinger, representing Rio Verde Engineering, reported that the gravel crushing bids will be opened on November 2<sup>nd</sup> and discussed the perceived competition between the county and the contractors bidding the crushing projects. It was reported that the Industrial Site project will be complete today, and the North Piney fence was discussed.

Billy Pape, Interim Waste Management Superintendent, reported on burn permits and discussed the C&D pit at the Marbleton Landfill and the compactor. After discussing the compactor and its condition, it was moved by Commissioner Burnett and seconded by Commissioner Bousman to purchase a demo compactor for the amount of \$357,019. The motion carried. Baler repair is scheduled for next week and geo tech work has been completed for the permit medication that is in progress.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to recess the meeting for an Executive Session, with Billy Pape, Interim Waste Management Superintendent, and Deputy County Attorney Matt Gaffney, in accordance with W.S. 16-4-405(a)(ii) to discuss personnel. The motion carried.

Pape was excused from the Executive Session, and it continued, to discuss another personnel matter.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to reconvene the meeting.

Shad Cooper, County Fire Warden, presented his monthly report, and approved a proposal to complete the gas line to the Fire Training Facility.

Sheriff KC Lehr reported that the State Livestock Investigators have been eliminated, but that Brand Inspectors are still employed in Sublette County. Lehr updated the Board on the security camera project.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to recess the meeting for an Executive Session, with County Attorney Clay Kainer, in accordance with W.S. 16-4-405(a)(ii) to discuss personnel. The motion carried.

It was moved by Commissioner Rawhouser and seconded by Commissioner Bousman to reconvene the meeting.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to authorize County Attorney Kainer and the Committee for the replacement of the Treatment Court Director to offer the job to fill the vacant position. The motion carried.

Kari DeWitt, representing Pinedale Fine Arts Council, presented a video, thanked the Board for its support and reported that PFAC had 10,741 contacts last year.

Old Business. Commissioner Rawhouser reported on the recent Landfill meeting and the WIR Board of Directors meeting in Pinedale. Commissioner Burnett concurred with Commissioner Rawhouser. Commissioner Bousman reported on a successful WIR Board of Directors meeting, the BLM gravel

meeting, and the Joint Chiefs funding application for the Forest Collaborative. Chairman Nelson reported on attending the WIR reception and was thanked for his performance.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Ultra Resources, Inc., \$1,189,977.35; and Ultra Resources, Inc., \$17,431.57.

Printed copies of the State of the County were reviewed.

The Board decided to cancel the November 21<sup>st</sup> breakfast.

The Board discussed scholarship requirements for the upcoming 2018-19 awards. It was agreed that the recipient needs to be enrolled in the upcoming fall semester, as a full time student, and that there will be no alternates designated. The Board agreed that a signed agreement with requirements and renewal information should be required from all recipients before receiving the funds. The importance of communication between the recipients and the County Clerk was discussed.

It was moved by Commissioner Burnett and seconded by Commissioner Bousman to recess the meeting for an Executive Session, with County Attorney Clay Kainer, in accordance with W.S. 16-4-405(a)(iii) to discuss litigation. The motion carried.

It was moved by Commissioner Burnett and seconded by Commissioner Bousman to reconvene the meeting.

Dennis Fornstrom, County Planner, thanked the Board for the opportunity to work for Sublette County and updated the Board on upcoming Planning and Zoning in November, and old business.
