

NOTICE OF HEARING

FORMATION OF DANIEL MOSQUITO IMPROVEMENT DISTRICT

On October 3, 2023, a petition was filed with the board of County Commissioners of Sublette County, Wyoming, for the formation of Daniel Mosquito Improvement District, to provide mosquito abatement.

The petition will be heard at a public hearing before the Board of County Commissioners in the Commissioners Meeting Room, Sublette County Courthouse, Pinedale, Wyoming at the hour of 10:45 a.m. on the 21st day of November, 2023.

The petition may be inspected in the Office of the County Clerk, Sublette County, Wyoming, during regular business hours.

The proposed method of financing the improvements or services will be by the levy of a tax upon future residents living within the addition to the existing District.

All interested person will be heard at the hearing. Written request for exclusion from, or inclusion of, land in the proposed district will be heard and considered.

The boundaries of the proposed district, generally, are:

EXCEPTING therefrom

That portion of the NE/4SE/4 of Section 35 being more particularly described as follows:

Beginning at the E/4 corner of said Section 35; Thence southerly, a distance of 1320 feet, more or less, to the S/16 corner thereof; Thence northwesterly 1826 feet, more or less, to the northwest corner of said NE/4SE/4; Thence easterly 1320 feet, more or less, along the northern boundary line of said NE/4SE/4 to the point of beginning.
