## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS DECEMBER 20, 2016

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse, in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, Jim Latta, Commissioners-Elect Tom Noble, Mack Rawhouser, and David Burnette, Joy Ufford and Stephen Crane of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of December 6, 2016 were approved and ordered filed on motion by Commissioner Latta and seconded by Commissioner Bousman. The motion carried.

The official bond for Kathryn Anderson, Treasurer for the Rural Health Care District, in the amount of \$5,000 was approved and ordered filed with the County Treasurer.

Butch Penton, Road and Bridge Superintendent, reported on the Elkhorn Big Sandy Road documents, that no work has been done on Dell Creek, and the closure of the Skyline Drive project was discussed.

The proposals for the Industrial Site Road project were presented. It was moved by Commissioner Bousman and seconded by Commissioner Latta to accept the proposal from R.S. Bennett Construction for the amount of \$2,035,029.00. The motion carried. The project will begin after June 30, 2017, and projects reports and weekly schedules will be required in the contract.

Skylar Wilson, County Surveyor, reported on plat reviews.

Ron Gordon, representing Waste Management, reported that the compactor has been repaired, and that different rippers are needed due to the depth of frost. The Board approved a request from Rio Verde Engineering to work on the DEQ permit amendment through the winter and defer payment for services until the end of the current budget or the next budget.

The Board approved and signed an Encroachment Agreement with the Pinedale Community Food Basket for the Town of Pinedale to build a shed roof addition onto the Food Basket building.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve the transfer of the Daniel Schoolhouse property to the Daniel Community Center, and authorizing the Chairman to sign the Warranty Deed. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Latta to appoint Rachel Weksler to an unexpired term on the Library Board. The motion carried.

Shad Cooper, County Fire Warden, presented his monthly activity report.

Jay Brower, Fairgrounds Manager, reported on housing the School District #9 buses, and the addition of events at the Events Center. The Board discussed the purchase of a sweeper for the Events Center floor. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve the purchase of an Advance Adgressor Scrubber for the amount of \$26,025.00. The motion carried.

Sheriff KC Lehr discussed the Detention Center door module upgrade, repairs to Durangos, and Title 25. Sheriff Lehr thanked Commissioner Latta for his service.

Old Business. Commissioner Latta reported on a recent WPLI meeting, with a Forest Service and BLM panel. Commissioner Bousman reported on the Wyoming Range Record of Decision that has been recently released, the WCCA Meeting in Lusk, the proposed UW budget reductions for 4-H programs, and WIR activities. Chairman Nelson had nothing to report.

In accordance with the public notice published in the <u>Pinedale Roundup</u>, on December 2, 2016, a public hearing was held for the following applications:

1. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, and the following resolution was adopted:

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION TO APPROVE THE APPLICATION OF NAISH DOG DEALINGS, LLC FOR A CONDITIONAL USE PERMIT TO ALLOW FOR THE DEVELOPMENT OF AN AIRPORT FOR ROTOR-CRAFT OPERATIONS (NON-FIXED WING AIRCRAFT) IN THE I-L DISTRICT, LOCATED ON LOT 6, AIRPORT INDUSTRIAL PARK SUBDIVISION.

2. It was moved by Commissioner Bousman and seconded by Commissioner Latta to approve the Deer Haven at Hoback Ranches Double Minor Subdivision, Ilia Zavialov, applicant, zoned R-R 10, being Tracts 7 and 10, Hoback Ranches Subdivision. The motion carried.

Representative Albert Sommers, Elaina Zempel, representing the Wyoming Business Council, and Rachel Grimes, Director of the Sublette County Chamber of Commerce, reviewed recent community meetings concerning deficient internet service in Sublette County. Meetings have been held in several communities with various providers. A public/private partnership was discussed. Citizens commented on their need for better service to conduct their business internationally.

Rachel Grimes, Director of the Sublette County Chamber of Commerce discussed remodeling the leased space in the Visitors Center. The Board agreed to have the Maintenance Department prepare an estimate for the requested work for the Board to consider.

Commissioner Bousman presented retiring Commissioner Jim Latta with a plaque from the Wyoming County Commissioners Association and thanked him, on behalf of the Association, for his work on WyoLink. Chairman Nelson presented Commissioner Latta with a plaque from the Board for his service to the citizens of Sublette County.
