OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS OCTOBER 3, 2017

The Board of County Commissioners met in regular session in the Commissioners Meeting Room of the Sublette County Courthouse in Pinedale, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, Lance Nixon of the <u>Pinedale Roundup</u>, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The official bonds for Margaret Kozeal, Treasurer for the Big Piney Cemetery District, in the amount of \$2,000, Maureen Rudnick, Clerk/Treasurer for the Town of Pinedale, in the amount of \$50,000; Kelly Sellers, Treasurer for the Weed and Pest District, in the amount of \$50,000; and Melvin Kinikin, Secretary/Treasurer for the Big Piney Marbleton Airport Board, in the amount of \$10,000, were approved and ordered filed with the County Treasurer.

The Board discussed the gravel crushing bid specifications and their addendums. Mike Jackson, representing Rio Verde Engineering, reviewed the gradation requirements and addendums. Contractors present were Mark Fear and Lance Biffle. The Board directed that all plan holders be notified of all changes.

Butch Penton, Road and Bridge Superintendent, reported the Espenscheid fence, Industrial Site Road project and weather, proposed Willow Creek Road easement, bank stabilization, and rocks on Skyline Drive. The Board directed the County Clerk to wait for the Land Trust approval of the Willow Creek project before advertising it for public hearing for the realignment of the road. Use of Forest Service Schedule A funding for other Forest Service roads was discussed.

Skylar Wilson, County Surveyor, reported on Middle Piney review, Hoback Ranches, and plat reviews.

Billy Pape, Interim Waste Management Superintendent, reported on repairing the Bale Building, fees, tire disposal, road repairs within the Marbleton Landfill. Ryan McGuire, representing M&M Transfer, expressed his support for consistency and charging for all items. Hauling the tires from the Marbleton Landfill was approved.

Becky Gregory, representing The Children's Learning Center, presented a program report and thanked the Board for its continued support.

Mandy Moffat, representing SAFV, presented a resolution for consideration proclaiming October 2017 as Domestic Violence Awareness Month. It was moved by Commissioner Bousman and seconded by Commissioner Noble to adopt Resolution No. 17-100315N proclaiming October 2017 Domestic Violence Awareness Month. The motion carried.

It was moved by Commissioner Noble and seconded by Commissioner Burnett to authorize the Chairman to sign the renewal of the BLM Lease for the Pinedale #1, Water Monitoring site. The motion carried.

Old Business. Commissioner Rawhouser reported on attending the recent WACO meeting in Cheyenne, and receipt of a thank you from Horton Spitzer for the lighting repair at the Visitor Center. Commissioner Noble reported on special districts, an upcoming broadband workshop, and land use plan review and update. Commissioner Burnette reported on Rural Health Care information. Commissioner Bousman reported on PILT Fly In on September 6, 7, and 8, BLM meetings in Washington, DC on the Planning process and the Secretary's Top 10 Priorities, the Forest Collaborative, and the Western Watersheds protest of the TNP. Chairman Nelson thanked Commissioner Bousman for his continued work of public lands issues and congratulated him for being chosen for the Wyoming County Commissioner Association recipient of the "Riding for the Brand" award.

Ranae Pape, Randy Belton, and Kathy Anderson discussed Suicide Awareness and Recovery activities.

County Fire Warden Shad Cooper and Sheriff KC Lehr reviewed the Communications Request for Proposals for Sublette County Simulcast. It was moved by Commissioner Noble and seconded by Commissioner Burnett to issue the Request of Proposals. The motion carried.

Todd Hurd, representing Forsgren and Associates, reviewed the following projects:

- 1. Storm Drain. The County will directly purchase the manhole for the project. It was moved by Commissioner Noble and seconded by Commissioner Burnett to award the project to R.S. Bennett Construction for the amount of \$11,380. The motion carried.
- 2. Pinedale Fire Hall. Stucco is still an issue. South side awnings are being designed.
- 3. Big Piney Library. Specifications for upgrading the lighting are being prepared.

Andre' Irey, Maintenance Superintendent, discussed the bullet proof glass for the Circuit Court, phone systems, Ice Arena operations, and the generator for the Marbleton Fire Training Facility.
