

**OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
NOVEMBER 21, 2017**

The Board of County Commissioners met in regular session in the Town Council Chambers of the Big Piney Town Hall in Big Piney, Wyoming, on this date at 9:00 a.m. with Andy Nelson, Joel Bousman, David Burnett, Tom Noble, Mack Rawhouser, and Mary Lankford, County Clerk present.

Chairman Nelson led those present in the Pledge of Allegiance.

The minutes of the preceding regular meeting of November 7, 2017 were approved and ordered filed on motion by Commissioner Burnett and seconded by Commissioner Noble. The motion carried.

The official bonds for Amy Commerer, Superintendent/Clerk for the Big Piney Cemetery District, in the amount of \$2,000; and John Godfrey, Clerk/Treasurer for the Rural Health Care District, in the amount of \$5,000 were approved and ordered filed with the County Treasurer.

Butch Penton, Road and Bridge Superintendent, reported on levy repair and road repair in Bondurant, and plowing and graveling.

Mike Jackson, representing Rio Verde Engineering, reported that the Industrial Site Road project is complete, with punch list items outstanding.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve and sign two applications to the Forest Service, for the Dell Creek road repair and a gravel pit access. The motion carried.

Billy Pape, Interim Waste Management Superintendent, reported that the new compactor had been delivered, that equipment and the building was being repaired, and discussed budget, reserves, hours of operation, staffing, permitting, and inspections. Commissioner Burnett scheduled a meeting at the Marbleton Landfill with Pape on November 27th. The Board discussed the LaBarge contract.

Chairman Nelson reported on the broken fire sprinkler at Aspen Grove.

The Board discussed the Legislative Dinner in Cheyenne on February 15th and meeting with our legislators before the session begins.

Shad Cooper, County Fire Warden, presented his monthly report, and reported on forming a Fire Investigation Team with the departure of Joe Sampson. The Board approved selling old equipment to Gooding, Idaho Fire Department.

Cooper reported that the RFP's for the Sublette County Simulcast project will be due in mid-January with five companies participating.

Jay Brower, Fairgrounds Manager, reported on the activities at the Fairgrounds and property improvements.

The following abatement petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Richard C. & Wendy C. It was moved by Commissioner Bousman and seconded by Commissioner Burnett to approve and send the proposed request for Cooperating Agency status for Land Use Planning Amendments for Conservation of Sage Grouse to Mary Jo Rugwell, State BLM Director. The motion carried.

The Board discussed submitted comments on the draft EA for the Big Sandy Reservoir Enlargement Project. Commissioner Bousman will prepare the comments.

After discussion with Mike Henn of the Sublette County Conservation District, it was moved by Commissioner Noble and seconded by Commissioner Bousman to authorize CLG to draft comments in objection to the Upper Green River EIS. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Burnett to authorize Connie Brooks to draft comments and request intervenor status on TNR. The motion carried.

Old Business. Commissioner Rawhouser reported on meeting with the Big Piney Marbleton Airport Board. Commissioner Noble reported on the BLM open house and broadband. Commissioner Burnett reported on Commissioners Corner. Commissioner Bousman reported on the BLM open house, a conference call with the Governor's Office, and upcoming meetings in Phoenix for the Western Governors Association and in Washington, DC for Forest Service manual development. Chairman Nelson reported on the ENDOW webinar and the 4-H Achievement Awards.

The Board discussed the extension of time to December 31st for the rock removal on Skyline Drive. Commissioner Noble reported the progress of the project and that three contractors were involved.

In accordance with the public notice published in the Pinedale Roundup on November 10, 2017, public hearing was held for the following:

1. It was moved by Commissioner Bousman and seconded by Commissioner Rawhouser to approve a conditional use permit application by David Gordon and Gwen Wisell Bogart to allow a dog kennel on 35 acres, zoned A-1, located in Section 17, T31N, R106W. The motion carried.

Jennifer Zook, Executive Director of the Sublette County Chamber of Commerce, discussed forming a 501(c)(3) non-profit for funding the operation of the Visitors Center. The non-profit would avail grant support for operations. It was moved by Commissioner Noble and seconded by Commissioner Bousman to support the formation of a 501(c)(3) non-profit to support the operation of the Visitor Center. The motion carried.

The Board reviewed the progress of the Sublette County Broadband project with Representative Albert Sommers, and Elaina Zempel of the Wyoming Business Council. Funding sources were discussed. It was moved by Commissioner Noble and seconded by Commissioner Burnett to provide a letter of recommendation supporting the Broadband plan provided by the work group, and that we further support the development of an application to the Wyoming Business Council for grants to support this project, and that we send a letter to ENDOW and the Governor seeking financial support for this project, further the Commissioners will seek private partnerships through an RFP process involving conduit and/or conduit and fiber to help match state grant dollars, further the Commission will write a letter to Jonah Inc, PEP, and Ultra asking for a letter of support for the project. The goal of this project is to support Gig internet service to the businesses districts of Sublette County through fiber and to provide redundancy and competition for internet and mobile services in the county. Further we hope to support fiber close to strategic tower sites, in order to support microwave internet providers' ability to serve the "last mile". The motion carried.

Jim Mitchell, Emergency Management Coordinator, and Jim Troutman, representing the National Weather Service in Riverton, reported that Sublette County has completed the requirements to be designated as a Storm Ready Community. A letter, certificate, and sign were presented by Troutman.

Mel Kinikin and Phil Stevens, representing the Big Piney Marbleton Joint Powers Airport Board, discussed funding for operations and the need for an equipment shed to store snow removal equipment. The Board agreed to provide the services of Forsgren and Associates for the equipment shed project.
