Welcome and Introductions

Getting Resources into Region 4 (Joel Bousman, Rich Stem, & Trisha O'Connor)
A 10-year plan is the best strategy to getting resources into Region 4 to help with efforts of the collaborative on the BTNF. Joint Chiefs & Great American Outdoor Act can produce funding for projects. Shared Stewardship may also enable future projects. Trish O'Connor would like to take a broader look at the BTNF to have a meeting with Lincoln County Collaborative to work together to develop a strategy for the BTNF. This will help industry be able to meet the demand of the future forest projects.

<u>Joint meeting with Greys River Forest Collaborative</u> (Trisha O'Connor) Next phase of forest collaboratives will be to work into a 10-year plan to give industry the ability to plan ahead as well.

Jessica added that when bringing the groups together, the groups could understand reasonable expectations for the group coming together, and what are the larger objectives across the landscape. Then the collaboratives could within their own groups identify projects that support those larger objectives.

This could roll into a full-time coordinator position if funding was available to coordinate the landscape-scale effort. Barry Tye added that the State Forestry does have someone like this in place.

Good Neighbor Authority – An agreement is in place with State Forestry, but another SPA would be necessary to fund the position. Trisha would add that **Kevin (Assistant Forest Supervisor)** would be a key player to getting this going.

BLM – Mark Randall is the contact.

No action was taken.



Blowdown Update (Rob Hoelscher)

The USFS has met with GIS experts to delineate blowdown areas using geospatial technology. The BT will deploy personnel this summer to QA the information to make sure that it is accurate.

Money has been set in place for this year to put crews on the ground to clear existing trails, based on priority use. The BT will be following the current regulations in place regarding chainsaw use.

Action Items:

- 1) Friends of the BT, Scott Kosiba could organize the volunteers from various groups to assist with blowdown. Rob indicated that he would be working with (Patrick USFS Recreation Manager) to move forward with this effort. *Action Item: Rob will report back to the group regarding this effort.*
- 2) Volunteers are willing to assist with cleanup of trails within the blowdown. *Action Item: Charter members are to identify specific trail areas that have been impacted by the blowdown by the next meeting if possible.*
- 3) Rob requested georeferenced photos from collaborative members to assist the USFS with their efforts to verify geospatial assessment of blowdown extent and impacts. Action Item: Collaborative members with blowdown documentation are to provide that information to Rob by the next meeting if possible.

Forest Lab Update (Rich Stem)

The USFS Forest Lab is a subset of the USFS that is a science-based lab located in Madison, Wisconsin that looks at different options for uses of wood. Their input will help the collaborative merge marketing and forest products as we develop project ideas. Has made contacts to bring the "right people" on board to attend a future tour for forest projects.

Phone call this week to identify regional reps with state and forest that can bring ideas, options and resources to the table.

Emphasized its important to have the right people on the ground. He is gaining support. Group is interested in draft acreage estimates and materials.

Should have more to report in the near future.

Action Item: Update from Rich at the next meeting.

Roadless Rule Update (Rich Stem)

The changes have "passed the mustard". The focus is to adjust technical boundary issues, not increase roadless areas. Boundary adjustments include Moose-Gyp road, Greys River, and areas within Jackson Ranger District. These were logical changes. Coming out in a week or two.



Action Item: No action needed.

CWPP Update (Shad Cooper)

Shared document regarding Community Wildfire Protection Plan required by the Healthy Forests Restoration Act. Shad feels the Collaborative and the CWPP should complement and coordinate what is happening on the Collaborative.

Action Item: Shad will continue to explore funding options and report back to the group.

- 5) Define project areas (review maps, overlapping polygons for wildlife values) Wyoming Range Mule Deer Project overlap with Fontenelle Fire
- 6) Aquatic management may benefit
- 7) Elk Feedgrounds need for enhanced access hunters, anglers and winter range for elk
- 8) Access to UG, boat launches; rivers and high elevation lakes
- 9) Timber Mgmt roadway cooridors, egress cooridors, migration coordiors, weed mgmt.

Jennifer Lamb- Group 3

 - a. List of designated trails to evaluate access
 - b. Create a "task force" to determine priorities within & systematic approach
- 2) Big Sandy and Elkhart Park find a strategy to reduce/minimize impact in these areas
- 3) CWPP important lever in the County unified support
 - a. Collaborative provide seed money to push the plan forward?
- 4) Chainsaws in wilderness to maximize efficiency

Shari Meeks - Group 4

- 1) Healthy Forests Projects
 - a. Blowdown top priority
 - i. Strategic and tactical plan to deal with the blowdown.
 - 1. Chainsaws in wilderness Regional Forester can assist with this issue.
 - 2. Logging treatments- if there is enough timber sales and is profitable in size, timber sale improvement funds can help to fund recreation efforts.
